The MorphoSmart[™] 1300 Series are based on a fast and cost-effective optical sensor and have a storage capacity of 500 users — or 1,000 templates.

Whether used for off-the-shelf enrollment or in custom-made applications, the MorphoSmart™ 1300 series are a flexible, ergonomic and cost-effective solution for the fast and secure processing of quality fingerprint images, with match-on-device and match-on-card functions that quarantee the faultless protection of information.
